2024-25 FAFSA Concepts

Applicant experience changes from current form

- Roles and contributors (e.g., Student, Parent, Spouse)
 - Parent Wizard
- Communications/invitations/workflows
- Consent/approval
- FSA ID login requirement
- Grouping/numbering of FAFSA data elements
- · Question order based on key decision points

FSA ID Process & The 2024-25 FAFSA

- Every student and contributor will need to create an FSA ID to complete the 2024-25 FAFSA online
 - FSA IDs will still take around 3 days to be verified and created
 - Schools should be encouraging students to create them well in advance of FAFSA filing
- FSA is still working on a process to allow individuals without SSNs to create an FSA ID

FAFSA Federal Tax Information (FTI) Approval

- An applicant and contributor (if applicable) must provide approval once each year
- If no approval, no Title IV aid eligibility

Draft 2024-25 FAFSA

- First draft: March 2023
 - · New look and significant reorganization
 - Contains several new questions required by the FAFSA Simplification Act
- Second draft: September 15, 2023

Second Draft FAFSA: Notable Changes

- · Language changes
 - Other Parent is now Parent Spouse or Partner
 - · Consent to Retrieve/Disclose FTI is now FTI Consent and Approval
- · More reorganization
- NASFAA wins
 - · Clarification that schools can't see gender and race/ethnicity answers
 - Better options for identifying first-generation status
- Comments due October 16

 - Still expected before FAFSA release date

Verification 2024-25

- <u>September 19, 2023 Federal Register</u> contains data elements and documentation requirements
- Dear Colleague Letter <u>GEN-23-12</u> contains additional information and suggested verification text

Parent of Record (Primary Parent) 2024-25

For dependent students with divorced or separated parents:

- Income and assets are reported for parent who provides most financial support over 12 months prior to filing FAFSA even if student does not live with that parent or lives with the other parent;
- 2. If neither parent provided support in 12-month period in #1, parent of record is parent who provided greater support during most recent year student received financial support from a parent; and then
- 3. If equal support is given; parent of record is one with the higher income or assets

Parent of Record (Primary Parent) 2024-25

- Parent student lived with most in past 12 months is no longer a criterion
- If one parent pays child support to the other parent, and that support amounts to more than half of student's support that parent is parent of record
- Parent of record is self-reported by the parent, and unless there is conflicting information, there is no requirement to verify or otherwise confirm which parent provides greater portion of support

Family Size 2024-25

- Family size replaces "household size"
- Uses IRS definition of dependents on tax return
- Federal tax information (FTI) is transferred directly from IRS to FAFSA via
 FUTURE Act Direct Data Exchange (FADDX)
- FAFSA contributor (student and/or parent) is given opportunity to manually update family size if it has changed since filing the tax return

Family Size 2024-25

For dependent student, include:

- Parent (and their spouse)
- Student
- Parent's dependent children, even if they live apart from parent because of college enrollment, if parent will provide more than half their support between July 1 and June 30 of FAFSA award year
- Other people if they live with parent and parent will provide more than half their support between July 1 and June 30 of FAFSA award year

Family Size 2024-25

For independent student, include:

- Student (and spouse)
- Student's dependent children, even if they live apart from student because of college enrollment, if student will provide more than half their support between July 1 and June 30 of FAFSA award year
- Other people if they live with student and student will provide more than half their support between July 1 and June 30 of FAFSA award year

Number in College 2024-25

- Number in college question still reported on FAFSA but will no longer be used in SAI calculation
 - · Statute still requires it to be listed on FAFSA
- In special circumstances beyond just having another family member in college, financial aid administrator (FAA) may use professional judgment (PJ) to adjust other data items related to COA or SAI to account for costs associated with additional family members in college

Untaxed Income 2024-25

Only untaxed income reported on FAFSA:

- Untaxed portions of Individual Retirement Account/Arrangement distributions (withdrawals)
- Untaxed portions of pension and annuity distributions (withdrawals)
- IRA deductions and payments to self-employed SEP, SIMPLE, and qualified plans
- Tax-exempt interest
- Foreign Earned Income Exclusion ("foreign income exempt from federal taxation")

Removed Untaxed Income Items 2024-25

- Untaxed payments to tax-deferred pension and retirement saving plans represented by codes D, E, F, G, H, and S in Box 12 of IRS Form W-2
- Housing, food, and living allowances paid to members of the military, clergy, others
- Veterans' benefits
- Worker's compensation
- · General category of "other untaxed income"
- General category of cash support or "money received by or paid on behalf of the student"

Emergency Financial Assistance 2024-25

- Other financial assistance (OFA, formerly EFA) excludes emergency financial assistance provided to student for unexpected expenses that are component of student's COA
 - Includes any grant or loan paid to student for unexpected expenses
- School alone determines whether unexpected expense is associated with a COA component


