What is Conflict Review?

Per 34 CFR 668.16(f): If an institution has reason to believe that an applicant's FAFSA information is inaccurate, it must verify the accuracy of that information.

- No matter if the student is selected for verification or not, the school must have an adequate internal system to identify conflicting information.
- DCL GEN 21-05 shined a light on conflict resolution with the temporary waiving of verification
- Confirming information that will change a student's eligibility for Title IV aid is accurate;
 even nondollar amounts (COA components)
- 34 CFR 668.16 (b)(3) & (f) requires the system to share information within the institution (not just within the FAO)
- If you have the information on your campus; you must evaluate the information

Unresolved conflict and Exemptions

 When aid has been disbursed and conflict is not resolved by the student, then aid must be returned by the student or PLUS borrower

• Exceptions:

- Conflicting information does not change EFC OR eligibility for aid
- Student passes away during the award year
- Student no longer enrolled and will not re-enroll

Development of Process

Determined areas that might cause conflicts outside the scope of verification


- FAFSA high school diploma/equivalent vs. Admissions records
- Parents' age compared to student's age
- Campus housing vs. student account charges
- Unusual Circumstance request vs. Campus emergency contact/HS guardian
- FAFSA VA benefits vs. institutional VA resources reported
