Awards Committee

The TASFAA Scholarship and Awards Committees have been combined for 2010-2011. Members included:

In late April, the committee invited everyone to apply for the Mack C. Adams Professional Development Scholarship. The scholarship was made available for the New Aid Officers Workshop (NAOW) in May. This scholarship was designed to assist financial aid professionals with the cost of attending TASFAA-sponsored training opportunities. Along with financial assistance, recipients also receive an opportunity to grow as a financial aid professional and make important connections with others in their field. Applications for the NAOW scholarship were made available in late April and recipients were notified by May 11. There were 6 applicants for the Mack Adams scholarship, and 5 scholarship recipients who received \$200 each toward their expenses associated with attending the NAOW. Due to budget constraints, the TASFAA board elected not to award the Mack Adams scholarship for the fall conference. Future scholarships are expected to be awarded using proceeds from upcoming fundraisers. The TASFAA Board will continue to discuss the future of the Mack Adams scholarship and its place and purpose within our organization.

Prior to sending out the 2010-11 service pins, the committee needed to replenish the supply of pins. The additional ordered stock of service pins was not available in time for the fall conference, so these pins will be mailed to recipients immediately upon delivery. All available service pins were given to attendees at the fall conference. The Awards Committee distributed/will distribute the following Years of Service pins:

This year's conference theme was "Pioneering New Trails." The conference committee worked very hard to provide the best training opportunities for TASFAA members. The conference was held on October 5-7, 2011 at the Arlington Convention Center, located within view of the Ballpark in Arlington as well as the Dallas Cowboys Stadium. We had sessions presented by the Department of Education, The Texas Higher Education Coordinating Board, NAFSAA Trainer Debra La Grone, NASFAA President and CEO Justin Draeger, and presenters from different schools. Presentations ranged from Professional Development to How to Use NASFAA Tools to Federal and State Updates.

The opening luncheon keynote speaker was NAFSAA President and CEO Justin Draeger. 55 people attended a tour of Cowboy Stadium on Wednesday night. We had fun at the Thursday night event, Game Night, which included dinner and live game shows like Family Feud and Minute To Win It, with Wii stations on the side that had Rock Band and Wii Resort games.

370 TASFAA members attended the conference this year, and we also raised \$1,653.00 from the silent auction and raffle to go toward the Mack Adams Scholarship. It was a challenging task to put on an informative and beneficial conference with limited funds, but I think the hard work by this year's conference committee was very successful because of the many compliments that we received.



Finance Committee

The objective of the Finance Committee is to explore investment avenues for TASFAA assets to provide additional financial security for the future of the association. Reports are made at board meetings when actions have been taken or the counsel of the board is required. TASFAA assets are currently managed by Rodgers Capital under the direction of Gary Rodgers who has advised the association since it began a formal financial management strategy in 1998.

The strategy of TASFAA has been to maintain an amount of cash on hand to fund the operating expenses of TASFAA while considering the projected income of the association from membership dues and conference registrations. We maintain a conservative stance with regard to income and an aggressive stance on expenses. The TASFAA Board receives reports from Rodgers Capital at each meeting and decisions are made based on recommendations presented and board discussion.



The 2010-2011 year has been a challenging one for most associations as the economic status of the United States and world financial markets has been uncertain and continues to be tenuous. At the February 8, 2011 board meeting the association voted to reinvest cash reserves in the amount of \$25,000 upon the recommendation of Rodgers Capital. TASFAA maintains enough liquid assets to allow access to funds within a four day period should they be needed to fund current activities. Currently TASFAA holdings are at about 55% equities and 45% in cash and holdings. Additional fund purchases were also made in May of 2011 at the recommendation of Rodgers Capital. In response to economic events in Europe, Rodgers Capital made a move to sell our position in the Swiss Franc after approval from the Finance Committee.

Despite current economic conditions, TASFAA remains financially stable and has managed to weather some contractual commitments for conference sites that were not positive for the association. While negotiating further out seemed to be appropriate at the time, industry changes caused a drop in membership and the associated revenue sources. The actions of the TASFAA Board over the past year have been consistent with sound fiscal responsibility as stewards of association resources.

Legislative Issues Committee

State

The 82nd Texas State Legislature ended on a positive note with funding cuts to the major grant programs not as deep as had been anticipated going into the session. The most significant piece of financial aid legislation to come out of the session was SB28 which added new eligibility requirements for Texas students wanting to participate in the TEXAS Grant Program. The legislation new requires state universities to use a priority model to award TEXAS Grants to students who meet higher academic standards coming out of high school beginning in 2013. HB3577 made changes to the Texas Educational Opportunity Grant that will allow TEXAS Grant eligible students to receive a TEOG grant at a community college if TEXAS Grant funding is not available. There were also the usual additions and changes to exemptions and waivers that come out of every legislative session. One important change was the addition of satisfactory academic progress requirements to some of the exemptions.

Federal

The U.S. Department of Education released its long anticipated final regulation on program integrity issues at the end of October 2010. These regulations, most of which became effective on July 1, 2011 included new requirements for satisfactory academic progress, consumer information, aid disbursement, ability to benefit, review of questionable high school diplomas, clock hour/credit hour conversion, and approval of non-degree programs for Title IV eligibility (a.k.a. Gainful Employment regs).

This Congress will be remembered mostly for its intense budget battles in the wake of the deep recession of 2008-2010 and the exploding national debt. Federal financial aid did not escape scrutiny in these budget battles. Several programs were eliminated with the signing of the FY2010 Budget, among them were the Leveraged Educational Assistance Programs (both LEAP and SLEAP), Byrd Scholarship, and Federal Direct Loan graduate student interest subsidies. Congress also reversed the decision of the previous Congress that established Two Pells in a Single Award Year. Effective July 1, 2011 the Pell grant program returned to a single schedule Pell award for students each year. Efforts to preserve the increase of the maximum Pell at \$5550 have been successful through 2011-2012.

TASFAA's Legislative Issues Committee was very busy during the Texas 82nd Legislature working with our officers and members providing alerts to members about upcoming hearings and votes on financial aid legislations. Much credit goes to our colleagues who made time to travel to Austin, write letters, and calls legislators and aides to be able to report the successes mentioned earlier in this report. There were too many volunteers in this effort to list here.

This past fall and spring, a significant amount of time was spent in working with NASFAA leadership and Congressional senate and representative offices to amend the guidance of



ED regarding payment of Pell for summer crossover payment periods. With the elimination of Two Pells in an Award Year, this guidance could have caused significant problems for students and schools in scheduled awards for the greatest benefit during the school year. The efforts were successful in Congress specifically voiding that guidance for the summer of 2011 in the FY2010 budget legislation. Efforts will need to continue to ensure that ED permanently amends its interpretation of the statutes and regulatory guidance in accordance with the intent expressed by Congress in this legislation.

Thank you for the opportunity to serve our great association and truly appreciate those who stepped in and helped lead the efforts during the 82nd Legislative session.

Membership Committee

The Membership Committee has been working to try and increase the numbers due to the high number of lending institutions that have chosen not to renew. Memberships for TASFAA have seen a slight decrease from previous years. This is not unusual due to the changes that the financial aid industry has experienced over the past few years and many institutional budgets being reduced. We currently have 208 member institutions that have renewed their membership or joined for the first time.

During our recap meeting we wanted to be able to continue to provide a substantial Texas Regional Training however we also needed to look at areas where we can eliminate or reduce costs for the agencies. We have suggested the following items in order to achieve this goal for 2011-12:

- No registration fee for participants will continue
- Participants will be expected to print all training handouts available online; TG will review number of attendees that did not pre-register in order to project how many on-site copies of handouts will need to be available (TBA)
- Participants will complete electronic evaluation survey after attending training
- Free Box Lunches will be served instead of catering
- Narrowed training down to five sites will reduce travel cost
- No folders or supplies will be offered

After reviewing the feedback the participants included in their evaluations we have considered the following:

- We will reduce our overall training time by including a working lunch (TBD)
- Include more interactive topics
- Suggestions from the participants on future trainings are being considered; however TASFAA will still review whether to incorporate NASFAA's Decentralized Training topic as an option as well. This year it is expected to cover SAP
- We wanted to see an improved collaboration among the three agencies and decided to include a session which all three agencies can present together: **Show What You Know(SWYK)***Joint presentation TG/TASFAA/THECB

The TASFAA Training is proud to have once again successfully executed the two introductory training programs offered by the association for new financial aid professionals each year. Both programs were well attended considering the current economic climate and the reduced budgets many schools may be facing. Many of the members of the Training Committee had served the previous year, and in some cases have been on the committee for several years. It is a great group of dedicated and hardworking people who worked tirelessly to make these programs a success.

On May 16 - 19, 2011 the annual New Aid Officers Workshop (NAOW) was held at the Hilton Arlington in Arlington, TX. This program is always a fun event as it incorporates teambuilding and networking activities along with session on financial aid fundamentals. Fifty-two new financial aid professionals participated in NAOW this year. Participants attended sessions ranging from student eligibility and verification to loan repayment and customer service in financial aid. This year, the workshop had a Rock Star theme that was incorporated throughout the presentations and activities. Participants were treated to a lively performance of "Financial Aid Rhapsody" (sung to the tune of Queen's Bohemian Rhapsody) given by the Training Committee. Participants were then challenged to work in teams to write and perform their own financial aid rock songs. The teams performed these for the TASFAA Board at dinner on Tuesday night and the Board served as judges. I think everyone in attendance would agree it was a fun night and it appears that the financial aid profession in Texas has some pretty creative people joining its ranks!

Most recently, the 2011 ABC Workshop took place on October 4th and 5th, at the Arlington Convention Center, just prior to

the annual TASFAA Fall Conference. A total of sixty-five new financial aid professionals attended the day and a half long workshop. Traditionally, this workshop has taken a "nuts and bolts" approach and includes sessions covering the basics of financial aid. Session topics included the application process, student eligibility, verification, satisfactory academic progress and professional judgment. Sessions also covered the federal grant and loan programs and packaging. We were once again pleased to have the Texas Higher Education Coordinating Board's Lyn Kinyon present a session on state programs to round out the agenda. Attendees completed evaluations of each session as well as the overall workshop and feedback was very positive overall. As always, the committee will take all suggestions for changes and improvements in to consideration when planning next year's training programs in order to continually improve the workshops and ensure they meet the needs of the association and its members.

Planning is already underway for the 2012 New Aid Officers Workshop. It will be held in Arlington, TX during the week of May 13, 2012 at the Sheraton Hotel. Based on feedback on evaluation forms completed at previous workshops, we intend to shorten the duration of the workshop slightly, while still incorporating the teambuilding and networking activities that attendees told us helped them make vital connections with other financial aid officers. The 2012 ABC Workshop will take place prior to the Fall Conference at the Omni Hotel in Corpus Christi, TX. The Training Committee is currently reviewing evaluations collected from the 2011 ABC Workshop attendees.

This year, beginning steps were taken to transition promotion and coordination of the TASFAA Mentor and Protégé Program under the responsibilities of the Training Committee. It is believed that since the Training Committee puts on the two primary training events for new hires in financial aid, this committee could effectively promote the mentoring program at these events. We have received a great response from new financial aid professionals wanting to be matched with an experiences mentor. Efforts are now underway to recruit more mentors to match with waiting protégés. Mentoring takes little time but can make a world of difference to some new to this profession. Mentors are simply asked to maintain contact with their protégé through periodic phone calls or email, and to be available for questions they may have. Mentors can share how they research questions, be a sounding board to bounce professional judgment scenarios off, or simply chat about how they handle the stressors of the financial aid office. There is no required amount of experience or specific title you need to have to be a mentor. We will attempt to match mentors and protégés from similar type schools if possible. Texas Association of Student Financial Aid Administrators Notes to Statement of Cash Receipts and Cash Disbursements Fiscal Year Ended October 31, 2010

Note 1 - Summary of Significant Accounting Policies

Purposes

The Texas Association of Student Financial Aid Administrators (TASFAA) is organized for educational and research purposes of its membership and shall not be operated for profit. In furthering these general purposes, TASFAA shall be dedicated to:

- Encouraging qualified students to pursue a higher education and assisting them to obtain the financial aid they need to achieve this goal.
- 2. The success of the students who pursue their higher education in Texas.
- Promoting the effectiveness of the student financial aid programs in the post secondary institutions of the state.
- Uniting and facilitating communication among all persons, agencies, organizations and institutions involved or interested in any phase of student financial aid administration in the state.
- Sponsoring those activities and services, which will serve its members and society and provide them a means of exchanging and distributing professional information and ideas.
- Promoting the professional development and competency of its members and others who support financial aid administration in the state.
- Maintaining and improving professional standards in the field of student financial aid administration.
- Stimulating creative and experimental activities in the financial aid field.

Basis of Accounting and Financial Statement Presentation

The Accounts of TASFAA are maintained on a cash basis. Accordingly, certain revenues and the related asset accounts are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligation is incurred.

Tax Status

TASFAA is exempt from federal income taxation under Section 501(c) (3) of the Internal Revenue Code.

Cash and Cash Equivalents

For purposes and convenience of reporting, cash and cash equivalents are considered to be all cash and certificates of deposit.



Investment Policy

Treasurer will keep cash on hand in an amount sufficient to meet expenses and to prevent overdrafts or service charges. Investments, stocks, bonds, and certificates of deposit amounts and distributions will be monitored by the Board.

Note 2 - ING Investment Account

TASFAA maintains an investment account at ING. This account is not reported on the statement of cash receipts and disbursements, as it does not meet the definition for cash and cash equivalents in this cash basis financial statement. A summary of activity in this account at fair market value is as follows:

Note 3 - Off-Balance Sheet Credit Risk

TASFAA maintains bank accounts as well as certificates of deposit at three banks. Accounts at an institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. Cash at all three institutions were under federally insured limits at October 31, 2010.

TASFAA maintains a brokerage account. This brokerage account is insured by the Securities Investor Protection Corporation. The SIPC provides protection for all securities registered in TASFAA's name in amounts up to \$500,000 per customer for failure of a brokerage house. At October 31, 2010, the balance at the brokerage house did not exceed this insured amount.

Note 4 - Subsequent Events and Date of Management Review

There are no subsequent events to report. Subsequent events were evaluated through December 20, 2010, which is the date the financial statements were available to be issued.
